Family and Children Services Director Duane Powell presented information on additional funding received from the Department of Corrections, Juvenile Services, to be distributed to Family and Children Service Center. The amount of the additional funds is \$6,729 and is requested to be distributed as follows:

Case Management \$4,229
Juvenile Intensive Supervision \$500
Juvenile Intake & Assessment \$2,000

EMPLOYEE HEALTH INSURANCE RENEWAL DISCUSSION:

Mr. Micah Boulanger of Encompass HR Solutions met with the Board to discuss the renewal of the employee health insurance for the period April 1, 2014 through March 31, 2014.

Commissioner Brown was joined to the session by telephone to enter into the discussion after consulting County Counselor. Mr. Boulanger advised the Board the increase in cost of the total premium would be \$1,000 more than the year 2013-2014. The following action was taken:

SHERIFF' DEPARTMENT - REPLACEMENT OF VEHICLE:

Sheriff Robert Dierks and Administrative Assistant Liz Schwatken met with the Board to discuss the replacement of a wrecked patrol vehicle. Sheriff Dierks requested the vehicle be replaced with a 2011 K9 Tahoe unit with 69,000 miles from Kansas Highway Patrol Surplus. The total cost of the vehicle with all equipment will be \$20,000. The unit will be added to the present loan at Community National Bank for vehicles with payment of insurance coverage on the wrecked vehicle made to the bank. An additional amount will be due on the wrecked vehicle not covered by the insurance and will be paid from the money paid by Enbridge Pipe Line for security provided by the Sheriff's Department. The following action was taken:

ACTION: A motion was made by Commissioner Rau to approve to the purchase of a 2011 K9Tahoe unit, 69,000 miles, with all equipment from the Kansas Highway Patrol Surplus in the amount of \$20,000. This unit will replace the wrecked patrol unit. Motion was seconded by Commissioner McManus.
