SHERIFF’S DEPARTMENT – OSSAWATOMIE STATE HOSPITAL:

Sheriff Robert Dierks and Administrative Assistant Liz Schwatken met with the Board. Sheriff Dierks advised the Board the State Hospital in Ossawatomie is undergoing some repairs and cannot house some of the prisoners that should be transported to the hospital. We will be retaining them here until the hospital can accommodate them.

They presented an Employee Status Change for one promotion due to a resignation and requested approval to advertise for a temporary part-time Dispatch position of 15 hours per week. The Board approved the request to post the position.

Mr. Brian Reedy appeared at the meeting to express his concerns over the response on getting the rental home repaired and livable. The Sheriff is working with Mr. Reedy and checking the status of the insurance.

COUNTY APPRAISER – AERIAL FLYOVER PRESENTATION:

The Board recessed to the Aerial Flyover Presentation at 10:15 AM. The presentation was by made by Jonathan Ballard of Pictometry Intelligent Images. The presentation is for a contract term of 6 years with 2 flights and the capture date of the winter of 2016. Three different proposals were demonstrated.
