**COUNTY ATTORNEY LARRY MARKLE – SENATE BILL 367:**

County Attorney Larry Markle brought information to the Board on a new Senate Bill 367 that has been in effect since July 1, 2016, January 1, 2017 and January 1, 2018. The bill reclassifies the Juvenile Justice Code. This will affect the inter-local agreement with Girard, facility and any other facility agreement for the same services.

According to Mr. Markle this bill will eliminate approximately 95% of the “way the county can send juveniles to detention”. This should be a reduction in the number of juveniles going to the Girard facility and should reflect the savings of funding in any agreements for juvenile detention.

Commissioner McManus is the County’s representative to Girard and he will report on how this bill affects the County.

**PUBLIC WORKS:**

Public Works Coordinator Robert Bever and Assistant Coordinator Jim Wright met with the Board to present the weekly written report. The following items were discussed:

At the Commission Meeting on July 11, 2016, Public Works provided cost estimate for the Shoofly Detour to be a total cost of \$27,760.84. Due to the cost of the project, the Board instructed Mr. Bever to check on alternative ways to cross and return to the Board with the costs.

It was decided the county will provide two (2) tubes, gravel, assume no liability and will not remove the structure when the bridge is completed.

**CLASS LTD – 2017 BUDGET:**

Mr. Scott Thompson, CLASS LTD Director and Mr. Phillip Chappuis, also from CLASS LTD, met with the Board to present the 2017 budget. Mr. Thompson explained some of the services provided to clients and also the reductions that have been made by the State to the funding for the facility. There was no action taken on the budget request at this time.

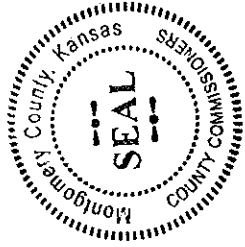
