TAXES ARE DUE BY MONDAY, MAY 11TH. DUE TO THE COVID-19 THE COURTHOUSE WILL BE CLOSED TO THE PUBLIC UNTIL MAY 18TH. KANSAS GOVERNOR, LAURA KELLY IS UNABLE TO EXTEND THE TAX DEADLINE. IF TAXES ARE NOT PAID BY MAY 11TH INTEREST WILL BE CHARGED. THE TAXES **MUST** BE PAID BY MAIL OR OVER THE PHONE USING A CREDIT OR DEBIT CARD. THERE WILL BE A 2.5% SERVICE CHARGE WHEN USING A CARD. A POSTMARK DATE OF MAY 11TH WILL BE ACCEPTED. THE MAILING ADDRESS IS, MONTGOMERY COUNTY TREASURER, P O BOX 767, INDEPENDENCE, KS 67301.

ALL VEHICLE **RENEWALS** MUST BE PROCESSED ON-LINE OR MAILED TO THE MONTGOMERY COUNTY TREASURER'S OFFICE, P O BOX 767, INDEPENDENCE, KS 67301. YOU MAY RENEW ON-LINE (<http://ikan.ks.gov>). YOU CAN REPRINT YOUR VEHICLE REGISTRATION NOTICE ON-LINE UNDER www.ksrevenue.org, CLICK ON DIVISION OF VEHICLES, ON DROP DOWN BOX SELECT TITLES AND TAGS, UNDER REGISTRATION INFORMATION CLICK ON PRINT REGISTRATION RENEWALS. THIS INCLUDES THE PIN NUMBER NEEDED FOR ON-LINE RENEWALS OR THE AMOUNTS FOR MAILING REGISTRATIONS IN. WHEN MAILING PLEASE INCLUDE A CURRENT CONTACT NUMBER AS WELL AS INSURANCE INFORMATION OR YOU MAY HAVE YOUR INSURANCE FAXED TO OUR OFFICE 620-330-1155. THE STATE HAS EXTENDED EXPIRATION DATES FOR MARCH AND APRIL RENEWALS FOR A PERIOD OF 60 DAYS FROM THE EXPIRATION OF THE GOVERNOR'S EXECUTIVE STAY AT HOME ORDER. I URGE EVERYONE TO GO AHEAD AND RENEW AS SOON AS POSSIBLE BY MAIL OR ON-LINE.

LIEN RELEASES MAY BE FAXED TO OUR OFFICE AT 620-330-1155.

A NEWLY PURCHASED VEHICLE: IF YOU NEED TO PROCESS TITLE WORK PLEASE CALL THE INDEPENDENCE OFFICE AT 620-330-1100. WE WILL COORDINATE WITH YOU TO MAKE ACCOMMODATIONS TO COMPLETE YOUR TRANSACTION. IF YOU HAVE A 60 DAY PERMIT THE EXPIRATION DATE HAS BEEN EXTENDED BY THE STATE. IF THE ORIGINAL EXPIRATION DATE WAS BEFORE MARCH 23, 2020 THE ADDITIONAL 60 DAYS DOES NOT APPLY. THE PERMIT WILL EXPIRE 60 DAYS FROM THE EXPIRATION OF THE GOVERNOR'S EXECUTIVE STAY AT HOME ORDER. WE WILL NOT PROCESS TITLE WORK WHILE WE ARE CLOSED TO THE PUBLIC UNLESS YOUR PERMIT IS EXPIRED. IF YOU TRADED OR SOLD A VEHICLE AND ARE GOING TO TRANSFER YOUR LICENSE PLATE YOU MAY USE THE LICENSE PLATE ON THE NEWLY PURCHASED VEHICLE

FOR 60 DAYS FROM THE PURCHASE DATE. THIS HAS ALSO BEEN EXTENDED FOR AN ADDITIONAL 60 DAYS.
